Sir/Madam,

This is with reference to school application on the subject cited above. I am directed to convey the approval of the Board for Affiliation i.e Upgradation to Senior Secondary Level as per details given below :

Sl. No.	The school is directed to ensure that :
1	The total number of section of the school shall be restricted to 18 on the basis of running sections. The total number of sections taken together for classes XI and XII should not be more than 1/3 of the number of section allowed. Further increase of section shall be subject to specific approval of the Board on the basis of the request of the school as per Affiliation Bye Laws and subject to the availability of room size of greater than 500 sq ft.
2	The form-D uploaded by the school along with building safety certificate is not in the name of school or in the name of society. Hence the school is directed to obtain the form-D in the name of school and upload on SARS portal within 3 months.
3	The ramp at the entrance is not seen in IC video and it is seen that the half portion of staircase is converted into ramp by placing a wooden plank on stairs to access upper floor, which is very steep and not disabled friendly. Hence, the school is required to reconstruct the ramp or to install lift to access upper floor and submit the compliance on SARAS portal within 3 months.
4	As per IC report, the school is having CWSN toilet 4 for boys and 3 for girls but these are not properly seen in the IC video. The school is directed to make separate CWSN toilets for boys and girls on each floor and submit the compliance within 3 month on SARAS portal. The circular No.5/2023 may be referred to for CWSN facilities.
5	Biology lab & composite lab have no seating & storage area there is no proper set up, specimens are not seen in Bio lab, some bottles and equipment are displayed on tables have no water connection. Chemistry lab and Maths lab are understocked. Chemistry lab does not have gas connection also. Hence the school is directed to setup all the labs as per SoP given by the Board and submit the compliance on SARAS portal within 3 months.
6	Indoor sports facilities seen in the IC video are inadequate. The school is required to make the sports facilities available as per SoP given by the Board.
7	The school shall conduct training of its teachers with CoE Chennai within 3 months and submit the compliance.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII , as the case may be

The approval of the Board as mentioned above, is subject to the following conditions:-

1. The school shall be responsible for its genuineness of the documents/ data/ information uploaded by the school. In case of any discrepancies, action will be initiated against the school as per Affiliation Bye -Laws-2018.
2. The school shall follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt. from time to time. The school will also abide by the conditions prescribed, if any, by the State Government concerned.
3. The School shall apply online for extension of affiliation along with the requisite fee and other documents as per Rule 10.3 of Affiliation Bye Laws.
4. The school shall go through the provision of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and keep a copy thereof for reference purpose and is also advised to regularly

visit CBSE websites i.e., <http://cbseacademic.nic.in/> & <http://cbse.nic.in/> for updates.

5. The school shall renew mandatory certificates from time to time.
6. The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity/activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.
7. Concerned Regional Office is requested to create new email id of school as per direction issued by controller of examination. This E Mail ID is used for communication with CBSE only.
8. The school shall not remove the documents and videography links in the mandatory disclosure section of its website.
9. The school shall follow the SOPs of the Board for its Laboratories, Library and sports facilities issued by the Board vide circular no 11 dated 04.10.2022.
